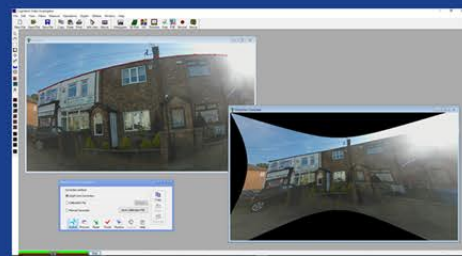
3D FaceFusion.

Plot facial features from multiple frames in a video sequence onto a 3D generated computer model to enhance an image in 3D space



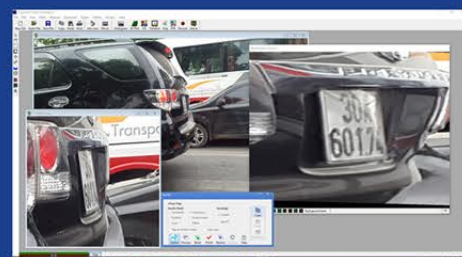
Geometric Lens Correction.

Correct lens distortion from fish eye and wide angle lenses in video and still images.



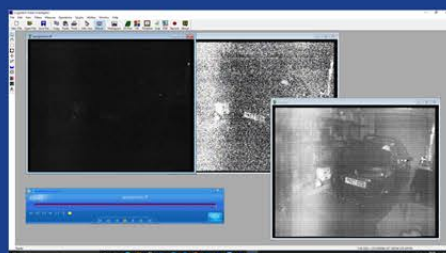
Rectification.

Adjust 3 dimensional aspects of a 2 dimensional images or video to reveal hidden data.



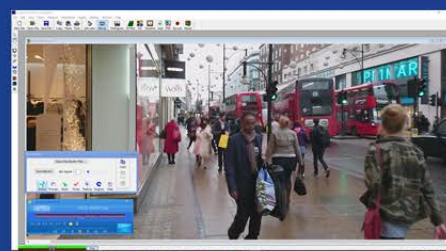
Average Frames

Combine multiple video frames into a new single enhanced still image. Use additional filters such as Histogram to alter brightness and contrast.



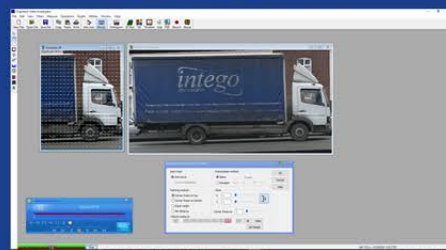
Automatic Face Blocker.

The MIDAS-DCL-SOLO comes with an integrated, user friendly hard drive cloning circuit. The unit can be used as a standalone HDD duplicator with no connection to the host MIDAS PC, delivering an exact 1 to 1 clone of the target hard drive including partition and boot sector information, the Host Protected Area (HPA) as well as user data.

Alternativley the unit can be switched into USB Mode allowing both the master and the target drive to viewed and browsed within Microsoft windows, whilst write protecting the master.
